6. Turner accepts no responsibility and shall not be liable to any person for any loss, damage, claim, cost or expense:
  - a. regardless of reason, which results in any delay or cancellation of the Event, or any technical problems or malfunction affecting the Event, or any lost, torn, defaced, illegible or expired admission tickets;
  - b. arising from any act of God or governmental authority, error, omission, interruption, strike or labour dispute, electrical outage, equipment failure, internet speed or communications failure, theft, destruction, fire or loss of facilities or any other cause beyond Turner's control, which may affect the Event or the issue of admission tickets; or

The Event will be photographed, videotaped and otherwise recorded; By entering the Event, you irrevocably consent to being filmed, photographed or videotaped and release all producers and users of such film or videotape (including Turner and its related bodies corporate) from any liability for loss or damage to persons or property for infringement of any rights and expressly authorize and permit use of your name, voice or likeness and all reproductions thereof throughout the world in perpetuity without limitation and without compensation thereof whatsoever.
